

# Youth Council Meeting October 8, 2014• 3:00–5:00 Bangor Savings Bank, Eames Learning Center, Bangor Maine

I. Chair Fletcher called the meeting to order at 3:07 p.m. Members introduced themselves.

### II. July 9, 2014 meeting minutes were reviewed.

## III. Recap Oct. 2 Board Development

TCWIB executive director recapped the recent board development workshop and strategy sessions which took place on October 2, 2014 at the Katahdin Region Higher Education and Training Center in East Millinocket.

Both the Aroostook & Washington Workforce Investment Board (Area 1) and the Tri County Workforce Investment Board (Area 2) met in separate morning sessions to hear relevant Labor Market Information on their region presented by Ruth Pease, Center for Workforce Research and Information (CWRI). Service providers also presented material on current programs and practices. MDOL's Joan Dolan presented information on apprenticeships and Ginny Carroll discussed new WIOA legislation changes. Finally, the individual boards brainstormed local priorities and areas of focus before breaking for lunch.

During lunch both boards came together and divided into six smaller mixed workgroups in order to identify projects and initiatives that all five counties can work collaboratively together on in the future and how to address challenges.

#### IV. EMDC Youth Program Update

EMDC's Denise Smith gave a report on the current youth enrolled, performance outcomes for the quarter as well as updates on Career Compass and outreach/recruitment efforts. It was explained that this last quarter there has been greater emphasis to the on boarding of new youth career advisors Jason and Aleigh. Current outreach efforts are more focused and strategically coordinated. Next meeting the team will present a summary snapshot of activities.

#### V. SWIB Younger Workers Committee

A brief discussion about the Maine State Workforce Investment Board's Younger Workers Committee occurred. Denise is the chair of the committee made up of individuals from all across the state, meeting once every other month.
